Mary had an auction tonight featuring a tractor and a snow blower.



DGE Mike and Joanne Ruby— The Rotary Foundation

Susan introduced DG Elect Mike Ruby and his wife Joanne. They are members of the Muscatine Club, both retired. Mike said he had made a goal in his year before becoming DG to visit all 64 clubs in the district so he could get to know the people of Rotary. He didn't want to walk into any club next year and not know individual members and the things the club did. So far they have visited 26 clubs! He said he called Troy to ask if he could come to our club in November and just hours later Susan called to inform him, not to ask him, that he was our annual speaker for the Rotary Foundation, fulfilling her obligation to Judge Hellwege. Mike has been a Rotarian since 1979 and he just had an article published in the September edition of Rotary Today which you may have seen! Mike encouraged everyone to attend the convention in Atlanta next year. He said in order to understand what Rotary is all about and how far it reaches you must sit in a convention hall with thousands of other Rotarians, all dressed in their native attire and talking their native language e shared that Dubuque Club is hiring a bus to take members and maybe that is something we would want to do. Mike was asked if he wanted the Power Point presentation for the Rotary Foundation and he told them, "No", he just wanted to talk about what the foundation meant to him. Mike congratulated our club on being a 100% PH Club, something that only a handful of clubs in District 6000 have achieved. He asked what we knew about the foundation and some of the replies were - We get something back from it through the years, it is highly rated on Charity Navigator and it is the engine that helps us do good in the world.

He stated that the foundation was 100 years old this year when "Service above Self" was born thanks to Arch Klumph, an early Rotarian. It has grown to be the main vehicle for how Rotary affects the many projects, locally and internationally. The foundation is not about the "Pins" we receive; it is about the money we give "through" Rotary, not "to" Rotary for the programs that change lives.

Last year 1,078 global grants were given out for a total of just under \$65 million dollars! It is one of the few grants available that will multiply from the amount a club starts out with. He gave an example of a club that raised about \$10,000 locally and by the time it had gone through the process it was up to \$80,000.

The levels of the Foundation are:

Sustaining Member – A member donates \$100/year to the foundation while you are a Rotarian

Paul Harris Society – A member donates \$1,000/year to the foundation while you are a Rotarian.

- 3. Benefactor A member provides a minimum of \$1,000 to the Foundation through their will.
- 4. Bequest Society A member provides a minimum of \$10,000 and up through their will
