Susan was gone on Wednesday but Bob and Vicki reminded everyone to turn in any donations for the Ride to end polio as soon as possible.


Passenger Car Painting Work Day

MARCI WEBB--ACCESS

Bob Herrick introduced Marci Webb who is a victim services counselor for ACCESS which stands for Assault Care Center Extending Shelter & Support. The mission of the non-profit organization is To address the roots and impact of domestic and sexual violence through services that enhance safety, empower survivors, and promote understanding and social justice within our community. Marci noted that ACCESS began providing services 40 years ago and she has been with the organization for 15 years-working now in the Boone and Greene County service area (their entire service area extends from Greene to Tama Counties). ACCESS is prepared to provide emergency support services 24-7 every day of the year and they have 22 full-time employees. Among the services provide are support and advocacy for victims of sexual abuse, domestic abuse services to help empower victims, and safe housing and shelter services. In addition to their full-time professional staff (certified counselors and victim advocates) they also have a network of volunteers trained to support the of the organization. mission Volunteers undergo 32 hours of

training and serve in capacities such as crisis line advocates, medical response advocates, legal advocates, and shelter advocates. Access receives funding from local governments, state and federal funds, faith organizations, civic groups, and local United Ways.
