COVID UPDATE


Matt indicated that at this time he thinks we may be able to resume meeting in person with a hybrid option (via Zoom) the last meeting in January. He called on Brian to provide an update who indicated that immunization of individuals in group 1A (frontline healthcare workers,

nursing homes, and caregivers) is underway in the county. As additional vaccine is made available immunization of individuals in the next group (1B) but it has not been determined exactly who will be included in that group as of yet. Brian said that there will be a website for residents to access to help determine when immunizations will be available and for whom. He envisions that there may be a ticket system used and vaccination sites (perhaps the fairgrounds) with big spaces that allow 30-50 vaccinations per hour while still maintaining social distancing.



BOONE ELEMENTARY SCHOOL PLAN UPDATE

Julie Trepas introduced Boone Elementary (Page and Lincoln) principal Autumn Seiler and Chad Houston of Kruck Plumbing to present an update about the upcoming bond issue vote for a new Boone Elementary School. Chad is chairing the “Yes Vote” committee this time. Chad noted that he hoped to pick Dave Cook’s brain since he was highly involved in previous successful school issue referendums. Autumn shared some history of the two buildings (Lincoln and Page) that the proposed bond issue would enable to be replaced. Page was built in 1961 and Lincoln opened in 1939—or four score and 2 years ago! She highlighted some of the structural and functional issues facing the two buildings including boiler heating systems that are well beyond their expected life span and difficulty controlling air and temperature quality (air conditioning, ventilation, allergens, etc.) in those buildings. They are both multistory buildings which present challenges in complying with ADA requirements and access for some students, staff, or visitors. The buildings

were built for the delivery of education in a different time and are not well designed for 21st century learning needs. They also have challenges with how they were designed with respect to “building access”. They were not designed for the sort of controlled access that is expected today. Some of masonry is crumbling (particularly at Lincoln) and the cost of fixing the problems to insure their continued structural integrity would be very high which would still not address the air quality, space, and access problems. By consolidating two buildings into one would allow resource to be allocated more efficiently. Chad and Autumn shared that it would be hoped that a new facility for Boone’s youngest learners would help attract and retain high quality staff members as well as attracting families considering locating in Boone. Land for the facility has been purchased south and east of the bend in Hawkeye Drive and the vote on the bond issue is scheduled for early March.
